**Meeting Notice Report:** Director reported that the meeting notice had been duly posted at the Humboldt County Courthouse, Humboldt County Library, County Annex, Winnemucca City Hall, and Humboldt County Website.

- 1. Call to order: The meeting was called to order at 6:01 pm
- 2. Public Comment and Discussion: There was no public comment at this time.
- 3. Consent Agenda: Any items appearing on the consent agenda can be pulled down and discussed in detail (for possible action): Trustee McComb motioned to bring the consent items down for discussion. Motion carried.

  - c. Routine Expenditures for May 9, 2019 June 5, 2019: Trustee Boni motioned to approve after some discussion and clarification about expenditures. Motion carried.

Information Only: Discussion of the Library's first annual Science Fair, our participation in the Edge Library Assessment, meeting with the State Library on LSTA grants from the 2019 fiscal year, upcoming NLA conference, and the Reading Coalition's first meeting and work on installing Little Libraries.
- 5. Discussion of the applications received so far from the county's applicant tracking system for the position of Library Director. For information only: H.R. Manager Abel del Real-Nava reported that the applicant tracking website had two applicants submit an application, with the window closing in a few weeks.

Discussion and Possible Action on changes made to the proposed Library Board of Trustees Policy Manual and adopting it: Discussion on the policies that were not applicable to the Board, the more general policies that were removed and minor changes and clarifying language added to the policies regarding the gift fund, friends of the library, and investigation into misconduct of the library director.
- 7. Information on the Inventory of the Humboldt County Library System's collection. For Information Only: Interim Director Jessica Anderson reported on the numbers of items missing from the collection after the library systems first complete inventory. Starting from a perceived collection of ~73,000 and ending up with an actual collection of just over 46,000 with 24,000 items having gone missing from the collection since it was digitized.

  - **c.** Parade/event participation: Basque Parade with the Bookmobile
