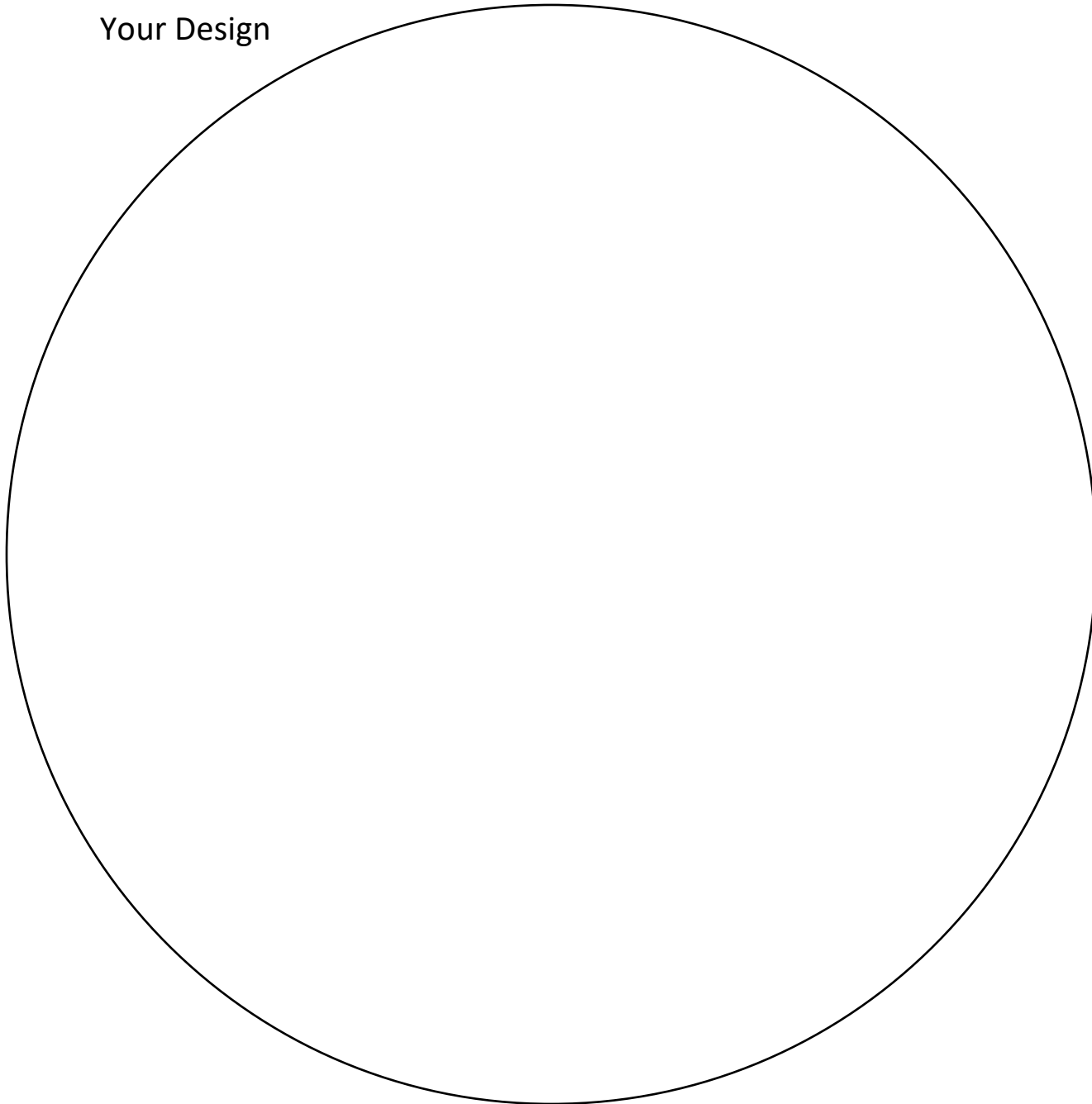

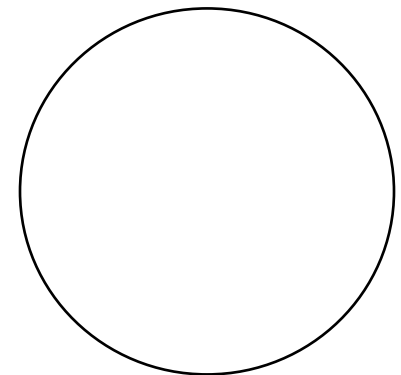

## **“I VOTED” STICKER ART DESIGN CONTEST OFFICIAL RULES**

By submitting an entry, you agree to be bound by the below stated “Official Rules” of the “I Voted” Sticker Art Design Contest:

1. **Sponsor:** This contest is sponsored by the Humboldt County Clerk’s Office, in conjunction with the Humboldt County School District.
2. **Eligibility:** Participants must:
  - Be a resident of Humboldt County, Nevada; and
  - Be currently enrolled in the 5<sup>th</sup> through 12<sup>th</sup> grade (or equivalent for home-schooled students) in Humboldt County, Nevada.
3. **Categories:**
  - A. 5<sup>th</sup> -8<sup>th</sup> Grade; and
  - B. 9<sup>th</sup>-12<sup>th</sup> Grade.
4. **How to Enter:** To enter you must submit the following items:
  1. Your original artwork, on the form provided by the Sponsor;
  2. Completed Contest Entry Form with completed parent consent for unemancipated minors under 18 years of age.

### **LATE ENTRIES WILL NOT BE ACCEPTED**

5. **Design Requirements:** Entries must comply with the following guidelines to be eligible:
  - All design and artwork must be completed by the student participant and only the student participant;
  - Only one contest entry may be submitted per participant;
  - The design must include the phrase “I Voted”
  - The dimensions of the design should be circular, and must be submitted on the design form that has been provided by the Sponsor;

## **“I VOTED” STICKER ART DESIGN CONTEST OFFICIAL RULES**

- Content cannot be sexually explicit or suggestive, or derogatory of any ethnic, racial, gender, religious, professional, national origin, color or age group;
- Content cannot promote alcohol, drugs, tobacco, firearms/weapons, or any political agenda, message or party;
- Content cannot defame, misrepresent or contain disparaging remarks about other people or companies;
- Designs must be entirely original and cannot contain trademarks, logos, trade dress, or copyrighted materials owned by others with out permission, in writing, by the owner;
- Content cannot feature the likeness, name, or any other indicia of private individuals, living or dead, without permission;
- Content cannot depict and cannot itself be in violation of any law or otherwise; and
- Content cannot communicate message or images inconsistent with the positive images and/or goodwill to which the Sponsor wishes to associate.

### **6. Judges and Criteria:**

Designs will be judged by an independent committee of local officials.

Designs will be evaluated by using the following criteria:

- Artistic Skill and Excellence;
- Meaningful and Consistent Theme; and
- Uniqueness of the Design.

### **7. Selection:**

Two participants, one from each category will be selected as winners, and awarded \$100.00 Chamber Checks, a plaque engraved with their name in recognition for winning the Contest, and have their designs printed and distributed as the official “I Voted” sticker at the 2024 Presidential Preference Primary, Primary, and General Elections in Humboldt County, Nevada.

### **8. Consent:**

By submitting any entry, submitting your original artwork and signing an Entry Form, you hereby agree and acknowledge that:

- I have read and agree to the terms and conditions of these Official Rules and to the release of liability described herein.

The Sponsor may edit the design as it deems necessary and/or appropriate.
